Official Rules**

**NO PURCHASE NECESSARY.**

By participating in the Explore Minnesota Trip Giveaway Sweepstakes with the Iowa Wild Hockey Club, LLC, you agree to these Official Rules, which are a contract, so read them carefully before participating. Without limitation, this contract includes indemnities to the Released Parties (defined below) from you and a limitation of your rights and remedies. The details and requirements for entry or participation in the Sweepstakes shall be provided by Iowa Wild Hockey Club, LLC ("Wild"). You must follow the directions provided by Wild and otherwise be bound by and follow these Official Rules to be eligible to receive a prize in connection with any Sweepstakes.

**1. ELIGIBILITY:** Explore Minnesota Trip Giveaway (the "Sweepstakes") is open only to legal residents of Iowa who are Twenty-one (21) years of age or older. Employees, officers, and directors (including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of the Sponsor and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win (as defined below). Entries will be chosen based at random based on the following of the entry process.
