The Iowa Wild "Learn To Play" Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

- **1. ELIGIBILITY.** The lowa Wild "**Learn To Play**" Sweepstakes (the "Sweepstakes") is only open to entrants who, as of the entry date, are permanent legal residents within a 40 mile radius of the City of Des Moines, lowa ("Territory") who are between four (4) and twelve (12) years of age with permission from a legal guardian, who are NOT currently nor have EVER been registered or affiliated with Des Moines Youth Hockey or USA Hockey. The Sweepstakes is void outside of the Territory listed herein and where prohibited or restricted by law. Employees, officers and directors of the lowa Wild Hockey Club, LP ("Wild"), and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies, and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. - **2. TIMING.** The Sweepstakes entry period begins at **9:00am** Central Time ("CT") on **July 19th, 2021** and ends at **6:00pm** CT on **August 20th, 2021** (the "Entry Period"). Wild's computer is the official timekeeping device for the Sweepstakes.
- 3. HOW TO ENTER AND COMPLIANCE WITH OFFICIAL RULES
 - a. HOW TO ENTER: There are two (2) ways to enter this Sweepstakes:
 - (1) During the Entry Period, go to www.iowawild.com and follow the instructions for entry. All entries must be received by the Wild during the Entry Period. Potential winners may be required to show proof of being the authorized entrant.
 - (2) In person at the Iowa Wild offices located at 730 Third Street, Des Moines, IA 50309.
 - b. COMPLIANCE WITH OFFICIAL RULES: Failure to submit all required information in the manner required in these Official Rules may result in disqualification. Entries will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Wild. Any submission that does not comply with any aspect of these Official Rules may be rejected by the Wild and the entrant disqualified.
- **4. AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of the Wild (including, without limitation, decisions regarding eligibility of entries, the selection of entrants and the winners, and the awarding of prizes), which are final and binding in all respects.
- 5. SELECTION OF WINNING ENTRY; ODDS; NOTIFICATION. On or about August 20thth, 2021 the Wild, in its sole discretion, will select no more than one hundred (100) winners from among all eligible entries received. Odds of being selected depend on the number of eligible entries received by the Wild during the Sweepstakes. The winner selected must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The winner will be notified by phone and will be required to execute a Liability waiver and Publicity Release. If the winner cannot be contacted within five (5) days of the first attempt to contact them then that winner may be disqualified

If winner cannot attend session for any reason, then the session is forfeited. The approximate retail value ("ARV") of the prize is \$650.
